#### ☐ Step 13: Surgical Coordinator Review

- $HgA1c \le 7.0\%$
- CPAP compliance and therapy report
  - 14 consecutive days > 4 hours at 100% usage to schedule surgery and compliance must be kept >80% to maintain surgery date
- Negative Nicotine screening
- Additional circumstance that will determine surgical date include but are not limited to:
  - Hospital Availability, Provider Availability, Type of Procedure, Type of Insurance

# ☐ Step 14: Surgery Preparation

- Review of surgery readiness may take up to 5-7 business days from insurance authorization at which time you will receive an e-mail notifying you of subsequent steps including:
  - Pre-Surgical Review class
  - Pre-Admission Testing and Medical Clearance
